NOTES:

1. **A member who is entitled to attend and vote at the meeting is entitled to appoint another person (such person need not be a member) as his proxy to attend instead of himself at the meeting. However, the proxy shall not have the right to speak at meeting and shall not be entitled to vote except on a poll.**
2. The instrument of proxy, in order to be effective, should be deposited at the registered office of the Company, duly completed and signed, not later than 48 hours before the commencement of the meeting. A proxy form is annexed to this report.
3. During the period beginning 24 hours before the time fixed for the commencement of the meeting and ending with the conclusion of the meeting, a member would be entitled to inspect the proxies lodged at any time during the business hours (between 10:00 A.M. and 5:30 P.M.) of the Company, provided that not less than three days of notice in writing is given to the Company.
4. In case of joint holders attending the Meeting, only such joint holder who is higher in the order of names will be entitled to vote at the Meeting.
5. A person can act as proxy on behalf of members not exceeding fifty and holding in the aggregate not more than ten percent of the total share capital of the company carrying voting rights.

Provided that a member holding more than ten percent, of the total share capital of the Company carrying voting rights may appoint a single person as proxy and such person shall not act as proxy for any other person or shareholder.

6. Corporate Members intending to send their authorized representatives to attend the Meeting pursuant to Section 113 of the Companies Act, 2013 are requested to send to the Company, a certified copy of the relevant Board resolution together with their respective specimen signatures authorizing their representative(s) to attend and vote on their behalf at the Meeting.

THE INSTRUCTIONS FOR MEMBERS FOR REMOTE E-VOTING ARE AS UNDER:-

The remote e-voting period begins on 19th September 2026 at 9 A.M. and ends on 22nd September 2026 at 5 P.M. The remote e-voting module shall be disabled by NSDL for voting thereafter. The Members, whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. 16th September 2026, may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being 16th September 2026.

How do I vote electronically using NSDL e-Voting system?

The way to vote electronically on NSDL e-Voting system consists of “Two Steps” which are mentioned below:

Step 1: Access to NSDL e-Voting system

A) Login method for e-Voting for Individual shareholders holding securities in demat mode

In terms of SEBI circular dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. 5. Password details for shareholders other than Individual shareholders are given below:

- a) If you are already registered for e-Voting, then you can use your existing password to login and cast your vote.
- b) If you are using NSDL e-Voting system for the first time, you will need to retrieve the 'initial password' which was communicated to you. Once you retrieve your 'initial password', you need to enter the 'initial password' and the system will force you to change your password.

How to cast your vote electronically on NSDL e-Voting system?

1. After successful login at Step 1, you will be able to see all the companies “EVEN” in which you are holding shares and whose voting cycle is in active status.
2. Select “EVEN” of company for which you wish to cast your vote during the remote e-Voting period.
3. Now you are ready for e-Voting as the Voting page opens.
4. Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on “Submit” and also “Confirm” when prompted.
5. Upon confirmation, the message “Vote cast successfully” will be displayed.
6. You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
7. Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

General Guidelines for shareholders

1. Institutional shareholders (i.e. other than individuals, HUF, NRI etc.) are required to send scanned copy (PDF/JPG Format) of the relevant Board Resolution/ Authority letter etc. with attested specimen signature of the duly authorized signatory(ies) who are authorized to vote, to the Scrutinizer by e-mail to cs.ranjeet@gmail.com with a copy marked to evoting@nsdl.com. Institutional shareholders (i.e. other than individuals, HUF, NRI etc.) can also upload their Board Resolution / Power of Attorney / Authority Letter etc. by clicking on "**Upload Board Resolution / Authority Letter**" displayed under "**e-Voting**" tab in their login.
2. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential. 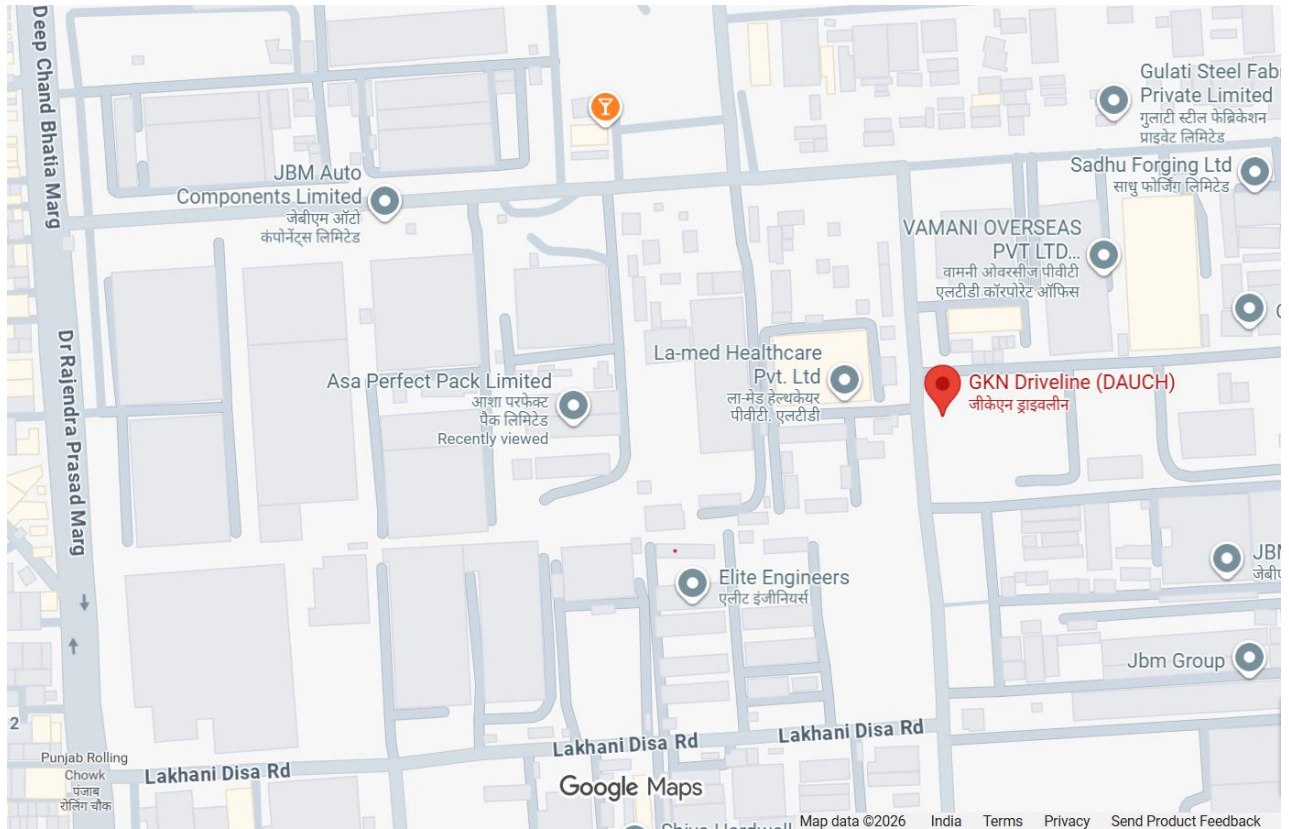

The Company's top-line showed a growth of 5.81% when current year is compared with previous year mainly due to increase in market demand. The profit before interest, tax and depreciation (EBITDA) is INR 2,089.89 Mn as compared to INR 1750.99 Mn in previous year (an increase of 19.35%). EBITDA is better than previous year mainly due to volume increase and reduction in commodity prices.

Your directors are satisfied that the accounts represent correct performance of the company and give a true and fair view of the state of affairs of the company as at March 31, 2026 and of the profit of the company for that year.

STATE OF THE COMPANY'S AFFAIRS AND OPERATIONS

The focus in 2025-26 continued to be on maintenance of harmonious industrial relations, people safety and business growth in line with market conditions. The business environment continued to be challenging in terms of volatile demand, global situation amid geopolitical tensions causing supply chain issues. Company responded to these conditions with agility. Inflationary pressures impacted financials, prompting us to find creative solutions and operate more flexibly.

Faridabad & Dharuhera - Operations delivered a strong year, maintaining 100% customer delivery and hitting all budgeted efficiency metrics while lowering year-end inventory (DIO) to 11.22. Health and safety initiatives drove 585 proactive hazard countermeasure bookings, though two isolated incidents occurred in Q2 and Q3 before achieving zero lost-time accidents in Q4. Quality performance peaked in the second half of the year with zero customer concerns and a GKN Platinum Award, despite a Q4 MSIL warranty issue that carried a \$60,000 cost impact. Strategically, the plant secured a 3-year factory license, completed 100% of year-end performance reviews, and captured four major new MSIL business wins, even as the MSIL YHB launch was rescheduled to December 2026 for a volume of 100,000 sets.

Pune and Kadi - During FY 2025-26, the Pune and Kadi plants continued to demonstrate strong performance in quality, safety, and operational excellence. Both plants received the prestigious Platinum Award in the GKN Quality Olympics, along with the Zero Defect Supplier Award from Maruti Suzuki and the Super Platinum Quality Award from Bajaj Auto Ltd.

Both facilities successfully maintained Zero Lost Time Accidents (LTA) throughout the year and celebrated National Safety Week 2026, reinforcing the Company's commitment to a strong safety culture. Key safety initiatives included BBS-based RADAR, SISCA, WPTRA, PIV assessments, and timely closure of improvement actions.

The IATF 16949:2016, ISO 14001, and ISO 45001 Surveillance Audits for both plants were completed successfully without any Major Non-Conformities.

The Company also achieved positive outcomes in customer and process audits, including Green Ratings in the SMG VSA Audit and TATA CVBU MSA Audit, successful completion of TATA PVBU PCPA Audits, DANA SSA CQI-9 and CQI-12 Audits, and the Fiat MPA Audit, reflecting continued focus on customer satisfaction, compliance, and operational excellence.

Oragadam - The plant achieved significant milestones in FY 2025-26, including receiving the Safety Champion Award from the Tamil Nadu Safety Professional Welfare Association and Toyota's prestigious Zero PPM Award for the 10th time, recognizing its outstanding quality performance. The plant also maintained a Level-1 performance rating with Renault-Nissan for 11 consecutive years and achieved a perfect annual score of 100/100, underscoring its commitment to operational excellence and customer satisfaction. Additionally, the plant successfully retained its Green Status with Maruti Suzuki for the fourth consecutive year, with continued improvements in audit scores. It also successfully passed all customer, IATF, and EHS audits without any major or blocking non-conformances.

No amount was transferred to reserves during the year.

The Board of Directors of the Company at its meeting held on 15th December 2025, declared an interim dividend of INR 35 per equity share (350%) of face value of INR 10 each for the year 2025-26. Same shall be considered as final dividend for FY 2025-26.

Tata demonstrates its strength via a "market saturation" strategy, ensuring there is an electric option for every demographic, from the entry-level hatchback to the premium SUV. Tata's dominance is best reflected in the leaderboard: they hold a staggering 30% of the slots in the Top 20 list, with six unique models (Nexon, Harrier, Punch, Tiago, Curvv, and Tigor). The collective strength of their top five models—Nexon (#2), Harrier (#4), Punch (#5), Tiago (#7), and Curvv (#10)—amounts to a massive 85,565 units.

MG's three-pronged attack (Windsor, Comet, ZS) effectively captures nearly 30% of the total market volume, proving that a tech-first ecosystem can successfully challenge legacy giants.

Mahindra's FY2026 data reveals a successful "clean-sheet" design strategy that has fundamentally revitalized the brand's electric prospects. There is a visible, performance-based divide between their purpose-built EV lines and their legacy-frame models. The market is clearly rewarding Mahindra's dedicated platforms.

PV Segment - FY27 Outlook

India's passenger vehicle (PV) industry is expected to maintain steady growth momentum in FY27, supported by GST rate cuts, sustained demand for utility vehicles (UVs), and a strong pipeline of new launches, even as weak monsoon concerns and geopolitical tensions in West Asia remain key risks, according to a latest report by ICRA.

The ratings agency expects wholesale PV volumes to grow 4-6% in FY27, moderating from the elevated base of FY26 but remaining resilient amid improving consumer sentiment and healthy replacement demand. The sector has also benefited from an extended summer wedding season and stronger traction for recently launched models.

April dispatches indicate healthy demand momentum

ICRA noted that wholesale passenger vehicle volumes rose 25% year-on-year to 4.4 lakh units in April 2026, as automakers maintained steady production schedules to cater to robust domestic demand. Sequentially, wholesale dispatches remained largely flat.

Retail sales, meanwhile, recorded a strong 16% YoY growth during the month, aided by the sustained impact of revised GST rates, healthy demand for new models and seasonal buying momentum. However, retail volumes softened sequentially compared with March 2026, when dealers had offered higher discounts to clear year-end inventory.

Inventory levels improved significantly, declining to 28-30 days in April 2026 from nearly 50 days a year ago and 60 days in September 2025,. The lower inventory levels indicate improved retail absorption and better production alignment by OEMs.

Utility vehicles continue to dominate industry volumes

Utility vehicles remained the primary growth driver for the domestic PV industry, accounting for 68% of overall industry volumes in FY26. While UVs continue to dominate consumer preference, ICRA noted that mini, compact and super-compact car segments have also witnessed a gradual recovery following the GST rate cuts.

Expect Demand momentum across segments and improving affordability dynamics. Export momentum also remained healthy, with passenger vehicle exports rising 13% sequentially in April 2026 as Indian automakers stepped up overseas shipments.

Maruti Suzuki India retained its leadership position in exports with a 49% market share in FY2026, followed by Hyundai Motor India.

ICRA, however, cautioned that inflationary pressures arising from the ongoing West Asia crisis, coupled with an uneven monsoon outlook, could weigh on consumer sentiment and remain key monitorables for the industry in the coming quarters.

HUMAN RESOURCES

During the year under review, the Human Resources function remained focused on supporting harmonious industrial relations, employee safety, employee engagement, talent development, and organisational effectiveness in alignment with business priorities. The Company continued to strengthen its people practices to support business continuity, capability building, and a performance-oriented work culture across its operations.

Human Resource Development focuses on the following strategic priorities:

1. Partnering with the business for organisational effectiveness
2. Employee experience and engagement
3. Talent acquisition, development, and succession planning
4. Equity, diversity, and inclusion
5. Employee and industrial relations

The HR strategy continued to focus on building a performance-driven culture in which employees are encouraged to contribute, develop their capabilities, and align individual performance with organisational goals. The Company remained committed to providing continuous support for employee development, fostering collaboration, and maintaining alignment between workforce priorities and business objectives.

1. Partnering Business for Organisation Effectiveness

Human Resources continued to provide strategic support to the business in areas such as organisation design, workforce planning, culture building, talent management, and policy deployment. The organisation structure and people practices were periodically reviewed and aligned to current and future business requirements with a view to improving efficiency, capability, and overall organisational effectiveness. Workforce planning initiatives remained focused on productivity optimisation, capability enhancement, and alignment of employee strengths with business needs.

2. Employee Experience and Employee Engagement

The HR team continued to partner with people managers to foster a positive employee experience through employee enablement and engagement initiatives. The Company encouraged a participative management culture supported by an open-door approach, enabling employees to raise individual or collective concerns and promoting constructive dialogue between employees and management. Regular forums and plant-level interactions continued to support employee engagement and grievance redressal.

Cross-functional platforms such as Quality Circles, Kaizen Circles, Canteen or Cafeteria Committee Meetings, Safety Committee Meetings, grievance handling procedures, CSR-related forums, and POSH awareness and redressal mechanisms supported employee participation and workplace engagement during the year. The Company also continued to invest in action planning and people-manager-led interventions to strengthen employee connect and enablement.

3. Talent Acquisition, Development and Succession Plan

The Company continued to focus on talent acquisition and retention strategies to support organisational capability in a competitive business environment. Talent development and succession planning remained aligned with business strategy, with emphasis on building leadership pipelines, enabling internal talent mobility, and addressing people-related risks including attrition and retention of critical talent. The learning

approach continued to encourage blended development through on-the-job exposure, coaching and mentoring, and structured learning inputs.

Training and development initiatives also continued to emphasise values, ethics, compliance, safety, health, and environmental awareness in order to support employee well-being and responsible business practices.

4. Equity, Diversity, and Inclusion

The Company remained committed to creating a workplace where employees are able to contribute fully, feel respected, and experience an inclusive environment. Efforts continued to strengthen awareness, dialogue, and interventions that support diversity, equity, and inclusion across the organisation.

Under the Prevention of Sexual Harassment (POSH) framework, the Company continued awareness and sensitisation initiatives to promote a respectful, inclusive, and safe workplace supported by an appropriate complaint resolution mechanism. These measures were aimed at reinforcing expected standards of behaviour and sustaining employee confidence in workplace processes.

5. Employee & Industrial Relations

The Company continued to work towards maintaining a progressive, positive, and healthy industrial relations climate in alignment with business requirements. Human Resources worked closely with business and plant leadership to monitor the industrial relations environment, formulate appropriate strategies, and manage relationships with trade unions and contract labour stakeholders, as applicable. The continued focus on harmonious industrial relations remained an important enabler for stable operations and business continuity during the year.

In addition, the Company maintained strong emphasis on employee safety and awareness, supported by safety-focused initiatives and workplace practices during the year. This remained closely aligned with the broader organisational objective of sustaining a safe, compliant, and responsible work environment.

PARTICULARS OF EMPLOYEES

The Company being an unlisted public Company, Section 197 of the Companies Act, 2013 read with Rule 5(2) and 5(3) of the Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014 are not applicable on the Company.

CORPORATE SOCIAL RESPONSIBILITY

Section 135 of the Companies Act 2013 and Rules made there under on Corporate Social Responsibility is applicable to the Company for the financial year 2025-2026. The company has earned profit that exceeds the threshold limit. In alignment with its CSR strategy, the Company has been continuing to contribute for betterment of the society and the community in which it operates, to help promote their sustained growth. The Company spent time, effort and money on different CSR projects focusing on infrastructure development of Government schools. Further CSR activity includes construction of toilets, classrooms, building renovation work in government Primary school. Setting up of STEM labs to promote STEM education at School level. Deploying apprentice trainees for their skill building under NAP scheme which increases employability of the youth.

Total amount spent on CSR activities during the FY 2025-26 was INR 18.26 Mn. The total expenditure required on CSR activities was INR 23.46 Mn. Shortfall of 5.2 Mn has been adjusted against excess spent carried forward from PY. Balance Surplus as on 31st March 2026 being carried forward to next year is INR 0.47 mn.

To further enhance our capabilities, we introduced a new group training kiosk on the shop floor. This interactive platform strengthens our safety training on Behavior-Based Safety (BBS), Lockout-Tagout (LOTO), and other critical safety modules.

Our comprehensive safety program remains robust, backed by the hard work, dedication, and heightened safety awareness of everyone at our plants. We take safety as our utmost priority. Our safety framework combines regular training, continuous safety education, investment in modern safety equipment, and strict adherence to protocol.

We remain fully committed to doing everything we can to protect our employees, visitors, and customers.

Pune & Kadi

The company remains committed to the continual improvement of Health, Safety, and Environmental (HSE) performance, with the ultimate goal of achieving zero preventable accidents. During April 2025 to March 2026, both the Pune and Kadi plants achieved Zero Lost Time Accidents (LTA), reflecting our strong safety culture and the collective commitment of all employees.

This achievement demonstrates dedication, accountability, and safety awareness across our operations. Safety remains our highest priority, and we continue to strengthen our performance through regular training, safety education, risk assessments, and strict compliance with safety procedures.

We actively promote Behavior-Based Safety (BBS) to encourage safe behaviors and proactive hazard identification. To further enhance our safety culture, we are implementing the S4 & E4 system across our plants. This initiative aims to make safety Personal, Positive, and Proactive, empowering every employee to take ownership of safety and contribute to a safer workplace.

Aligned with the GKN Global Safety Vision, "Everyone goes home safe, every day," we remain dedicated to protecting our employees, contractors, visitors, customers, and all stakeholders through continuous improvement and investment in safety programs and technologies.

ORA

The Company remains fully committed to the continual improvement of its Health and Safety performance, with the overarching goal of achieving zero preventable accidents across all operations.

During the period April 2025 to March 2026, the Company recorded one minor Lost Time Accident (LTA) involving a trainee employee. While our overall safety performance remains strong, we recognize that even a single incident is one too many and continue to strengthen our preventive measures.

To further enhance our safety culture and employee awareness, we have implemented a comprehensive safety management program focused on training, education, accountability, and compliance. A dedicated safety training curriculum has been established, and mandatory safety training has been automated through our Safety Kiosk System, ensuring consistent and effective delivery of safety education across the workforce.

In addition, the Company continues to invest in safety equipment, technology, and proactive risk management initiatives to minimize workplace hazards and reinforce safe behaviors. Through these efforts, we are fostering a culture where safety is a shared responsibility and an integral part of everyday operations.

We remain steadfast in our commitment to providing a safe and healthy workplace for all employees, contractors, visitors, and customers, while continuously improving our systems and processes to prevent incidents and achieve our long-term vision of **Zero Harm**.

In line with the requirements of the Companies Act, 2013 the Company has adopted a consistent policy on Related Party Transactions. It is ensured that proper reporting, approval and disclosure processes are in place for all transactions between the Company and Related Parties.

The Board and Audit & Risk Management Committee specifically deals with the review and approval of Related Party Transactions keeping in mind the potential or actual conflicts of interest that may arise because of entering into these transactions. The company takes omnibus approval of estimated Related party transactions in the beginning of the financial year. All actual Related Party Transactions are placed before the Audit Committee for review and approval. Approval is obtained for Related Party Transactions in each of the board meeting for transactions which are of repetitive nature and / or entered in the Ordinary Course of Business and are at Arm's Length. At the time of transfer pricing audit, all the Related Party Transactions are subjected to independent review by a reputed accounting firm to establish compliance with the requirements of Related Party Transactions.

The Board gives significant attention to, and accepts its responsibility for, the company's risk management internal control and internal financial controls. The Board has systems in place which optimizes the Company's ability to manage risk in an effective and appropriate manner.

The Audit and Risk Management Committee is responsible for reviewing the ongoing control processes and reporting to the Board on the operation of the systems of internal control, internal financial controls and risk management. The Board uses feedback from Audit & Risk Management Committee to form its own view on the effectiveness of the systems.

Risk Management

Company's enterprise risk management facilitates a common, company-wide method to the assessment of risks and the way in which these are monitored, managed and controlled. Risk profiling is undertaken at plant, function/business stream. A web-based software tool is used which provides a consistent set of risk definitions and a common approach to probability and impact. A broad range of risks is considered, including those relating to strategy, operational performance, financial, product engineering and technology, business reputation, human resources, health and safety, and the environment. Consolidated 'risk maps' are reviewed by company management, the Audit & Risk Management Committee and the Board.

Internal Audit

Internal audit is part of the Company's Internal Control on Financial Reporting Programme (ICOFR). The Company has appointed M/s R Mahajan & Co, Chartered Accountants, who conducts internal audit of the company and its five plants on quarterly basis, the auditors submit plant wise and areas wise report every quarter. Internal audit reports of the Plants are presented to the Executive Team of the Company during Plant Review Meetings. Action plan is drawn on each observation and same are closed in timely manner. Internal audit areas include capital expenditure, statutory compliances, procurement & logistics, quality, inventory management, customer collection, dispatches, loans & advances, legatrix audit, intercompany transactions and employee cost etc. Internal Audit recommendations are analyzed and if found appropriate, are implemented.

Transfer of Unclaimed Dividend to Investor Education and Protection Fund

The Company has transferred the unpaid/unclaimed dividend amounts lying with it to the unpaid dividend account as at the end of financial year 2025–26. Further, no amount was required to be transferred by the Company to the Investor Education and Protection Fund.

Internal Financial Controls

The Company has adopted adequate policies and procedures for robust internal controls to ensure orderly conduct of business, adherences to such policies and procedures, safeguarding of assets, true and fair conduct of business, prevention and detection of fraud & errors, accuracy and completeness of accounting records and timely preparation of reliable information. CGRF is another initiative of the Company on ICOFR. The Company has constituted a compliance, governance and risk framework at Plant and at Central level. The framework is bestowed with the responsibility to review compliances, governance and risk on periodic basis, draw road map to resolve the issues and implement the decisions taken for effective internal controls on compliances, governance and management of the Risks.

Standard Processes

The standard processes for all functions i.e., finance, human resource, purchasing, application engineering, supply chain, manufacturing engineering, sales & marketing, quality, production and operations developed and implemented during the period in all the plants of the Company. Effective adherence to processes is good sign of good internal control system in the Company.

Reporting & Integrity Process

Your Company observes strong controls and robust reporting processes to ensure that true and fair view of company's affairs are reported. Reporting and integrity processes of the Company are audited on quarterly and yearly basis.

1. Corporate information

GKN Driveline (India) Limited ('the Company'), a public limited company domiciled in India, was incorporated on July 25, 1985. The Company is engaged primarily in the manufacture and sale of driveshafts to original equipment manufacturers (OEMs) in the automobile industry. The Company has five manufacturing locations in India at Faridabad, Dharuhera, Oragadam, Pune and Kadi. The address of its registered office is Plot No 270, Sector 24 Faridabad, Haryana.

On February 03, 2026, Dauch Corporation (formerly known as American Axle & Manufacturing Holdings, Inc.) completed the acquisition of Dowlais Group plc, the ultimate parent company of GKN Driveline (India) Limited. Consequently, the ultimate holding company of GKN Driveline (India) Limited has changed from Dowlais Group plc to Dauch Corporation.

The financial statements for the year ended March 31, 2026, were approved by the Board of Directors and authorized for issue on August 14, 2026.

2. Material accounting policies

2.01 Basis of preparation

(i) Statement of Compliance

The financial statements of the Company have been prepared in accordance with The Indian Accounting Standards (hereinafter referred to as the "Ind AS") as notified by Ministry of Corporate Affairs ('MCA') under the Section 133 of the Companies Act, 2013 ("the Act") read with the Companies (Indian Accounting Standards) Rules, 2015, as amended, and other relevant provision of the Act.

(ii) Basis of preparation and presentation

The financial statements have been prepared in accordance with Ind AS and accounting principles generally accepted in India on historical cost basis except for certain financial instruments which are measured at fair value at the end of each reporting period, as explained in relevant accounting policies mentioned below. Historical cost is generally based on the fair value of the consideration given in exchange of goods or services. The accounting policies followed in preparation of the financial statements are consistent with those followed in the preparation of financial statements for the year ended March 31, 2026 except for certain amendments in Ind AS and the Act as notified by MCA.

a) Operating cycle

Operating cycle is the time between the acquisition of assets for processing and their realisation in cash or cash equivalents. Based on the nature of products and the time between the acquisition of assets for processing and their realisation in cash and cash equivalents, the Company has ascertained its operating cycle as twelve months for the purpose of current and non-current classification of assets and liabilities.

b) Current and non-current classification

The Company presents assets and liabilities in the financial statements based on current or non-current classification according to the Company's operating cycle.

All amounts disclosed in the financial statements and the accompanying notes have been rounded off to the nearest million as per the requirement of Schedule III of the Companies Act 2013, unless otherwise stated. Previous year figures have been regrouped / reclassified to make comparable with the current year figures for better presentation. However such regrouping / reclassification are not material to overall financial statements.

(iii) Use of estimates and judgements

In preparing the financial statements in conformity with accounting principles generally accepted in India, management is required to make judgements, estimates and assumptions that may affect the application of accounting policies and reported amounts of assets and liabilities and the disclosure of contingent liabilities as at the date of financial statements and the amounts of revenue and expenses during the reported period. Actual results may differ from those estimates. Estimates and underlying assumptions are reviewed at each balance sheet date. Revisions to accounting estimates are recognised in the period in which the estimates are revised and future periods affected.

(iv) Going Concern

The board of directors, at the time of approving the financial statements, have reasonable expectation that the Company has adequate resources to continue its operational existence for the foreseeable future. Thus, they continue to adopt the going concern basis of accounting for preparation of financial statements.

2.02 Cash and cash equivalents

Cash and cash equivalents comprise cash in hand, balances with banks and similar institutions, and short-term deposits which are readily convertible to cash and are subject to insignificant risks of changes in value. For the purpose of statement of cash flows, cash and cash equivalents consist of cash in hand, balances with banks and short-term deposits, as defined above, net of outstanding bank/book overdrafts as they are considered an integral part of Company's cash management.

2.03 Statement of cash flows

Cash flows are reported using indirect method, whereby Profit before tax reported under Statement of Profit and loss is adjusted for the effects of transactions of non-cash nature and any deferrals or accruals of past or future cash receipts or payments. The cash flows from operating, investing and financing activities of the Company are segregated based on available information.

2.04 Property, plant and equipment

Property, plant and equipment are stated at cost or deemed cost and subsequent costs thereto net of GST input credit less accumulated depreciation and impairment.

Cost of acquisition includes expenditure that is directly attributable to the acquisition of the items. Such assets are classified to the appropriate categories of property, plant and equipment when completed and ready for intended use.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any item accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to profit or loss during the reporting period in which they are incurred.

Depreciation methods, estimated useful lives and residual value

Depreciation on property, plant and equipment is provided on the straight-line method ('SLM'), over the useful life prescribed in Schedule II to the Companies Act, 2013 ('Act') or useful life determined based on technical evaluation and past trends, upto the estimated residual value of the depreciable assets, as follows:

All assets, the individual written down value of which at the beginning of the year is Rs. 5,000 or less, are depreciated at the rate of 100%. Assets purchased during the year costing Rs. 5,000 or less are depreciated at the rate of 100%. An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

Capital work-in-progress comprises the cost of property, plant and equipment that are not yet ready for their intended use on the reporting date.

The Company has elected to continue with the carrying value of all of its property, plant and equipment recognised as of April 1, 2016 (the transition date) measured as per the previous GAAP and use such carrying value as its deemed cost as of the transition date.

2.05 Intangible assets

Intangible assets with finite useful lives (viz. software) that are acquired separately are carried at cost less accumulated amortization and accumulated impairment losses, if any. Amortization is recognized on a straight-line basis over the period of three years or the period of license. The estimated useful life and amortization method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, and are recognised in profit or loss when the asset is derecognized.

The Company has elected to continue with the carrying value of all of its intangible assets recognised as of April 1, 2016 (the transition date) measured as per the previous GAAP and use such carrying value as its deemed cost as of the transition date.

2.06 Impairment of tangible and intangible assets

At the end of each reporting period, the Company reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any).

Intangible assets with indefinite useful lives and intangible assets not yet available for use are tested for impairment at least annually, and whenever there is an indication that the asset may be impaired.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss.

When an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

2.07 Inventories

Inventories are valued at cost or net realizable value whichever is lower with due allowance being made for obsolete and slow-moving items. Cost is determined on First in First out (FIFO) basis.

The cost of raw materials and stores and spares comprises all cost of purchase, costs of conversion and other costs incurred in bringing inventories to their present location and condition. The cost of finished goods and work in progress comprises raw materials, direct labour, other direct cost, related fixed and variable production overheads. Costs of purchased inventory are determined after deducting rebates and discounts. Net realizable value is the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sale.

Machinery spares (other than those supplied along with main plant and machinery, which are capitalised and depreciated accordingly) are charged to the statement of profit and loss on consumption.

2.08 Revenue recognition

The Company derives revenues primarily from sale of manufactured goods.

Revenue is measured at the fair value of the consideration received or receivable. Amounts disclosed as revenue are net of returns, discounts, price reductions and Goods & Service tax.

The Company recognises revenue when the amount of revenue and its related cost can be reliably measured, and it is probable that future economic benefits will flow to the entity and degree of managerial involvement associated with ownership or effective control have been met for the Company's activity.

Revenue from the sale of driveshaft is recognized at the point in time when control is transferred to the customer, depending upon contractual terms this may be at the point of dispatch or acceptance by the customer. The revenue recognised is the transaction price as it is the observable selling price per product.

Contracts are reviewed to identify each performance obligation relating to a distinct good or service and the associated consideration. A performance obligation is identified if the customer can benefit from the good or service on its own or together with other readily available resources, and it can be separately identified within the contract. This review is performed by reference to the specific contract terms.

The Company's revenue is derived from the single performance obligation to transfer primarily its products under arrangements in which the transfer of control of the products and the fulfilment of the Company's performance obligation occur at the same time. Revenue from the sale of goods is recognized when the Company has transferred control of the goods to the buyer and the buyer obtains the benefits from the goods, the potential cash flows and the amount of revenue (the transaction price) can be measured reliably, and it is probable that the Company will collect the consideration to which it is entitled to in exchange for the goods.

Discount to customers are based on certain percentages agreed with the customers, which are typically earned by the customer over an annual period. These are allocated to performance obligations and are recorded as a reduction in revenue at the point of sale based on the estimated future outcome. Due to the nature of these arrangements an estimate is made based on historical results to date, estimated future results across the contract period and the contractual provisions of the customer agreement.

The Company procured / manufactured tooling, which is explicitly funded by the customer, whether up-front or over time, and is included within part of a broader production contract.

The Company has the practice of recovering the market movement of steel, obsolete inventory, prototype development and exchange rate from its customers. The revenue for these recoveries is booked only after settlement of prices with customers.

Revenue from services is recognised on rendering of related services to the customers and when there is no uncertainty in receiving the same.

Export incentives under various schemes are accounted for in the year of export.

2.09 Other income

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Company and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

2.10 Foreign currencies

The functional currency for the Company is determined as the currency of the primary economic environment in which it operates. For the Company, the functional currency is the local currency of the country in which it operates, which is Indian Rupees (Rs.).

In preparing the financial statements of the Company, transactions in currencies other than the entity's functional currency (foreign currencies) are recognised at the rates of exchange prevailing at the dates of the transactions. At the end of each reporting period, monetary items denominated in foreign currencies are re-translated at the rates prevailing at that date.

Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation of monetary assets and liabilities denominated in foreign currencies at year end exchange rates are recognised in the statement of profit or loss.

2.11 Financial instruments

Financial assets and financial liabilities are recognised when the Company becomes a party to the contractual provisions of the instruments.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or

deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in the statement of profit or loss.

Financial assets

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

Classification of financial assets

Debt instruments that meet the following conditions are subsequently measured at amortised cost (except for debt instruments that are designated as at fair value through profit or loss on initial recognition):

- The asset is held within a business model whose objective is to hold assets in order to collect contractual cash flows; and
- the contractual terms of the instrument give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Debt instruments that meet the following conditions are subsequently measured at fair value through other comprehensive income (except for debt instruments that are designated as at fair value through profit or loss on initial recognition):

- the asset is held within a business model whose objective is achieved both by collecting contractual cash flows and selling financial assets; and
- the contractual terms of the instrument give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

All other financial assets are subsequently measured at fair value.

Effective interest method

The effective interest method is a method of calculating the amortized cost of a debt instrument and of allocating interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the debt instrument, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

A financial asset is held for trading if:

- it has been acquired principally for the purpose of selling it in the near term; or
- on initial recognition it is part of a portfolio of identified financial instruments that the Company manages together and has a recent actual pattern of short-term profit-taking; or

- it is a derivative that is not designated and effective as a hedging instrument or a financial guarantee.

Impairment of financial assets

The Company applies the expected credit loss model for recognizing impairment loss on financial assets measured at amortized cost, lease receivables, trade receivables and other contractual rights to receive cash or other financial assets and financial guarantees not designated as at FVTPL.

For trade receivables or any contractual right to receive cash or another financial assets that result from transactions that are within the scope of Ind AS 115, the Company measures the loss allowance at an amount equal to expected credit losses. The expected credit losses on trade receivables and other financial assets are estimated based on the Company's historical credit loss experience, adjusted for factors that are specific to the debtors, general economic conditions and an assessment of both the current as well as the forecast direction of conditions at the reporting date. The Company follows simplified approach for recognition of impairment loss allowance for Trade receivables.

The application of the simplified approach does not require the Company to track changes in credit risk. Rather, it recognises impairment loss allowance based on lifetime ECLs at each reporting date, right from its initial recognition. For recognition of impairment loss on other financial assets and risk exposure, the Company determines whether there has been a significant increase in the credit risk since initial recognition. If credit risk has not increased significantly, twelve months ECL is used to provide for impairment loss. However, if credit risk has increased significantly, lifetime ECL is used. If, in the subsequent period, credit quality of the instrument improves such that there is no longer a significant increase in credit risk since initial recognition, then the entity reverts to recognising an impairment loss allowance based on a twelve months ECL. ECL is the difference between all contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the entity expects to receive (i.e., all cash shortfalls).

Derecognition of financial assets

The Company derecognizes a financial asset when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another party. If the Company neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Company recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Company retains substantially all the risks and rewards of ownership of a transferred financial asset, the Company continues to recognise the financial asset and also recognizes a collateralized borrowing for the proceeds received.

On derecognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable and the cumulative gain or loss that had been recognised in other comprehensive income and accumulated in equity is recognised in profit or loss if such gain or loss would have otherwise been recognised in the statement of profit or loss on disposal of that financial asset.

On derecognition of a financial asset other than in its entirety (e.g. when the Company retains an option to repurchase part of a transferred asset), the Company allocates the previous carrying amount of the financial asset between the part it continues to recognise under continuing involvement, and the part it no longer recognises on the basis of the relative fair values of those parts on the date of the transfer. The difference between the carrying amount allocated to the part that is no longer recognised and the sum of the consideration received for the part no longer recognised and any cumulative gain or loss allocated to it that had been recognised in other comprehensive income is recognised in profit or loss if such gain or loss would have otherwise been recognised in profit or loss on disposal of that financial asset. A cumulative gain or loss that had been recognised in other comprehensive income is allocated between the part that continues to be recognised and the part that is no longer recognised on the basis of the relative fair values of those parts.

2.12 Financial liabilities and equity instruments

Classification as debt or equity

Debt and equity instruments issued by the Company are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an entity after deducting all its liabilities. Equity instruments issued by the Company entity are recognised at the proceeds received, net of direct issue costs.

Repurchase of the Company's own equity instruments is recognised and deducted directly in equity. No gain or loss is recognised in profit or loss on the purchase, sale, issue or cancellation of the Company's own equity instruments.

Financial liabilities

All financial liabilities are subsequently measured at amortized cost using the effective interest method or at FVTPL.

However, financial liabilities that arise when a transfer of a financial asset does not qualify for derecognition or when the continuing involvement approach applies, financial guarantee contracts issued by the Company, and commitments issued by the Company to provide a loan at below-market interest rate are measured in accordance with the specific accounting policies set out below.

a) Financial liabilities at FVTPL

Financial liabilities are classified as FVTPL when the financial liability is either contingent consideration recognised by the Company as an acquirer in a business combination to which Ind AS 103 applies or is held for trading or it is designated as FVTPL.

A financial liability is classified as held for trading if:

- it has been incurred principally for the purpose of repurchasing it in the near term; or
- on initial recognition it is part of a portfolio of identified financial instruments that the Company manages together and has a recent actual pattern of short-term profit-taking; or
- it is a derivative that is not designated and effective as a hedging instrument.

Financial liabilities at FVTPL are stated at fair value, with any gains or losses arising on remeasurement recognised in profit or loss. The net gain or loss recognised in profit or loss incorporates any interest paid on the financial liability and is included in the 'Other income' line item.

However, for non-held-for-trading financial liabilities that are designated as FVTPL, the amount of change in the fair value of the financial liability that is attributable to changes in the credit risk of that liability is recognised in other comprehensive income, unless the recognition of the effects of changes in the liability's credit risk in other comprehensive income would create or enlarge an accounting mismatch in profit or loss, in which case these effects of changes in credit risk are recognised in the statement of profit or loss. The remaining amount of change in the fair value of liability is always recognised in profit or loss. Changes in fair value attributable to a financial liability's credit risk that are recognised in other comprehensive income are reflected immediately in retained earnings and are not subsequently reclassified to the statement of profit or loss.

b) Financial liabilities subsequently measured at amortized cost

Financial liabilities that are not held-for-trading and are not designated as at FVTPL are measured at amortized cost at the end of subsequent accounting periods. The carrying amounts of financial liabilities that are subsequently measured at amortized cost are determined based on the effective interest method. Interest expense that is not capitalized as part of costs of an asset is included in the 'Finance costs' line item.

The effective interest method is a method of calculating the amortized cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or (where appropriate) a shorter period, to the net carrying amount on initial recognition.

c) Foreign exchange gains and losses

For financial liabilities that are denominated in a foreign currency and are measured at amortized cost at the end of each reporting period, the foreign exchange gains and losses are determined based on the amortized cost of the instruments and are recognised in 'Other income'.

The fair value of financial liabilities denominated in a foreign currency is determined in that foreign currency and translated at the spot rate at the end of the reporting period. For financial liabilities that are measured as at FVTPL, the foreign exchange component forms part of the fair value gains or losses and is recognised in the statement of profit or loss.

d) Derecognition of financial liabilities

The Company derecognizes financial liabilities when, and only when, the Company's obligations are discharged, cancelled or have expired. An exchange between with a lender of debt instruments with substantially different terms is accounted for as an extinguishment of the original financial liability and the recognition of a new financial liability. Similarly, a substantial modification of the terms of an existing financial liability (whether or not attributable to the financial difficulty of the debtor) is accounted for as an extinguishment of the original financial liability and the recognition of a new financial liability. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in the statement of profit or loss.

2.13 Employee benefit costs

Retirement benefits and termination benefits costs

a) Defined contribution plans:

Payments to defined contribution retirement benefit plans are recognised as an expense when employees have rendered service entitling them to the contributions. Payments made to state-managed retirement benefit plans are accounted for as payments to defined contribution plans where the Company's obligations under the plans are equivalent to those arising in a defined contribution retirement benefit plan.

The Company contributes towards Employees' provident fund, Employees' pension fund, Employees' state insurance fund and superannuation fund managed by LIC for certain employees. The contribution paid/ payable under the scheme is recognized during the period in which the employee renders the related service.

b) Defined benefit plans:

- (i) The Company provides for gratuity, a defined benefit plan (the "Gratuity Plan") covering all employees in accordance with the Payment of Gratuity Act, 1972 without any limits on the amount. The Gratuity Plan provides a lump sum payment to vested employees at retirement, death, incapacitation or termination of employment, of an amount based on the respective employee's salary and the tenure of employment. The Company funds the benefits through annual contributions to Life Insurance Corporation of India (LIC) under its Group's Gratuity Scheme.

The Company's liability and the cost of providing benefits is determined using the projected unit credit method, with actuarial valuations being carried out at the end of each annual reporting period. The present value of the defined benefit plan liability is calculated using a discount rate which is determined by reference to market yields at the end of the reporting period on government bonds.

Remeasurement, comprising actuarial gains and losses, the effect of the changes to the asset ceiling (if applicable) and the return on plan assets (excluding net interest), is reflected immediately in the balance sheet with a charge or credit recognised in other comprehensive income in the period in which they occur.

Remeasurement recognised in other comprehensive income is reflected immediately in retained earnings and is not reclassified to profit or loss. Past service cost is recognised in profit or loss in the period of a plan amendment or curtailment, and the date that the Company recognizes related restructuring costs.

Net interest is calculated by applying the discount rate at the beginning of the period to the net defined benefit liability or asset.

Defined benefit costs are categorized as follows:

- a) service cost (including current service cost, past service cost, as well as gains and losses on curtailments and settlements)
- b) net interest expense or income; and
- c) remeasurement

The Company presents the first two components of defined benefit costs in profit or loss in the line item 'Employee benefits expense'. Curtailment gains and losses are accounted for as past service costs.

The liability or asset recognised in the financial statements in respect of gratuity plans is the present value of the defined benefit obligation at the end of the reporting period less the fair value of plan assets.

c) Other Long-term employee benefits:

Accumulated compensated absences, which are expected to be availed or encashed beyond 12 months from the end of the year are treated as other long term employee benefits. The Company's liability is actuarially determined (using the Projected Unit Credit method) at the end of each year. Discount rates used for determining present value of the obligation under the defined benefit plan, are based on the market yield on Government Securities as at the balance sheet date. Actuarial gains and losses arising from past-experience and changes in actuarial assumptions are credited or charged to the standalone statement of profit and loss in the year in which such gains or losses are determined.

d) Short-term employee benefits:

All employee benefits falling due wholly within twelve months of rendering the service are classified as short-term employee benefits. The benefits like salaries, wages, short term compensated absences etc. and the expected cost of bonus, and exgratia are recognized in the period the related service is rendered at undiscounted amount of benefits expected to be paid in exchange for that service.

The cost of short-term compensated absences is accounted as under:

- (a) in case of accumulated compensated absences, when employees render the services that increase their entitlement of future compensated absences; and

2.14 Leases:

At inception of a contract, the Company assesses whether the contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified assets for a period of time in exchange for consideration.

Where a lease arrangement is identified, a liability to the lessor is included in the Balance Sheet as a lease obligation calculated at the present value of minimum lease payments. A corresponding right-of-use asset is recorded in property, plant and equipment.

The Company recognises a right-of use assets and a lease liability at the lease commencement date except for lease with a term of twelve months or less (short-term leases) and low value leases. For these short-term and low value leases, the lease payments associated with these leases as an expense on a straight-line basis over the lease term.

Lease term is a non-cancellable period together with period covered by an option to extend the lease if the Company is reasonably certain to exercise that option: and period covered by an option to terminate the lease if the Company is reasonably certain not to exercise that option.

The right-of-use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct cost incurred, less any lease incentive received. The right-of-use asset is subsequently depreciated using the straight-line method from the commencement date to the end of the lease term, unless the lease transfers ownership of the underlying assets to the Company by the end of the lease term or code of the right-of-use assets reflects that the Company will exercise a purchase option. In that case the right-of-use assets will be depreciated over the useful life of the underlying assets.

They are subsequently measured at cost less accumulated depreciation and impairment losses. Right-of-use asset are depreciated over the shorter of asset's useful life and the lease term on a straight-line basis. Right of use assets are evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable

The lease liability is initially measured at the present value of the lease payments to be paid over the lease term at the commencement date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Company's incremental borrowing rate. Generally, the Company uses its incremental borrowing rate as the discount rate. Subsequently, the lease liability is measured at amortised cost using the effective interest method.

Lease payments to be made under reasonably certain extension options are also included in the measurement of the liability. The lease payments are discounted using the rate of interest implicit in the lease. If that rate cannot be readily determined, which is generally the case for leases in the Company, the lessee's incremental borrowing rate is used, being the rate that the individual lessee would have to pay to borrow the funds necessary to obtain an asset of similar value to the right-of-use asset in the similar economic environment with similar terms, security and conditions.

The Company accounts for each lease component within the contract as a lease separately from non-lease components of the contract in accordance with Ind AS 116 and allocates the consideration in the contract to each lease component on the basis of the relative stand-alone price of the lease component and the aggregate stand-alone price of the non-lease components.

Lease payments are apportioned between finance expenses and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance expenses are recognised immediately in the statement of profit and loss, unless they are directly attributable to qualifying assets. Variable lease payments are recognised in the statement of profit and loss in the period in which the condition that triggers those payments that occur.

2.15 Earnings per share

Basic earnings per share is computed by dividing the profit / (loss) after tax (including the post-tax effect of exceptional items, if any) by the weighted average number of equity shares outstanding during the year. Diluted earnings per share is computed by dividing the profit / (loss) after tax (including the post-tax effect of exceptional items, if any) as adjusted for dividend, interest and other charges to expense or income (net of any attributable taxes) relating to the dilutive potential equity shares, by the weighted average number of equity shares considered for deriving basic earnings per share and the weighted average number of equity shares which could have been issued on the conversion of all dilutive potential equity shares. Potential equity shares are deemed to be dilutive only if their conversion to equity shares would decrease the net profit per share from continuing ordinary operations. Potential dilutive equity shares are deemed to be converted as at the beginning of the period, unless they have been issued at a later date. The dilutive potential equity shares are adjusted for the proceeds receivable had the shares been actually issued at fair value (i.e. average market value of the outstanding shares). Dilutive potential equity shares are determined independently for each period presented. The number of equity shares and potentially dilutive equity shares are adjusted for employee share options and bonus shares, if any, as appropriate.

2.16 Taxation

Income tax expense represents the sum of the tax currently payable and deferred tax.

Current tax

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the Statement of Profit and Loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Company's current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible

Such deferred tax assets and liabilities are not recognised if the temporary difference arises from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realized, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Company expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the assets to be recovered.

Current and deferred tax for the year

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

2.17 Provisions, contingent assets and contingent liabilities

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation.

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (when the effect of the time value of money is material).

When some or all of the economic benefits required to settle a provision are expected to be recovered from a third party, a receivable is recognised as an asset if it is virtually certain that reimbursement will be received, and the amount of the receivable can be measured reliably.

Contingent liabilities are disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources will be required to settle or a reliable estimate of the amount cannot be made.

Litigations often involve complex legal/regulatory issues and are connected with a high degree of uncertainty. Accordingly, the assessment of whether an obligation exists on the balance sheet

2.18 Insurance claims

Insurance claims are accounted for on the basis of claims admitted / expected to be admitted and to the extent that the amount recoverable can be measured reliably and it is reasonable to expect ultimate collection.

2.19 Segment reporting

Operating segments are reported in a manner consistent with the internal reporting provided to the chief operating decision maker. The board of directors assess the financial performance and position of the Company and makes strategic decisions and therefore the board would be the chief operating decision maker or 'CODM', within the meaning of Ind AS 108 "Operating Segments". The CODM evaluates the Company's performance and allocates resources based on the dominant source, nature of product and nature of risks and returns. The Company's primary business segment is manufacturing of driveshafts accordingly there is only one reportable business segment which is consistent with the internal reporting to the chief operating decision maker ("CODM").

2.20 Dividends paid

Dividend to shareholders is recognised as a liability and deducted from equity, in the year in which the dividends are approved by the shareholders. However, interim dividends declared by the Board of directors, which does not need shareholders' approval, are recognised as a liability and deducted from retained earnings, in the year in which the dividends are so declared.

2.21 Use of estimates and judgments

The preparation of these financial statements in conformity with the recognition and measurement principles of applicable Ind AS requires the management of the Company to make estimates and assumptions that affect the reported balances of assets and liabilities, disclosures relating to contingent liabilities as at the date of the financial statements and the reported amounts of income and expense for the period presented.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimates are revised, and future periods are affected.

Key source of estimation of uncertainty at the date of the financial statements, which may cause a material adjustment to the carrying amounts of assets and liabilities within the next financial year, is in respect the following:

- Useful lives and Impairment of Property, Plant and Equipment and Intangible Assets – (Also refer Note 2.04, 2.05 and 2.06)

The estimated useful lives, residual value, depreciation/ amortisation method and impairment are reviewed periodically, with the effect of any changes in estimate

accounted for on a prospective basis. This reassessment may result in change in depreciation/ amortisation and impairment expense in future periods.

- Contingent liabilities and provisions for contingencies – (Also refer Notes 2.17, 13 and 32)

The contingent liability is a possible obligation that arises from past events whose existence will be confirmed by the occurrence or non-occurrence of one or more uncertain future events beyond the control of the Company or a present obligation that arises from past events but is not recognised because:

(i) it is not probable that an outflow of resources embodying economic benefits will be required to settle the obligation; or

(ii) the amount of the obligation cannot be measured with sufficient reliability.

The Company evaluates the obligation through Probable, Possible or Remote model ('PPR'). In making the evaluation for PPR, the Company takes into consideration the industry perspective, legal and technical view, availability of documentation/agreements, interpretation of the matter, independent opinion from professionals (specific matters) etc. which can vary based on subsequent events. The Company provides the liability in the books for probable cases, while possible cases are shown as contingent liability. The remote cases are not disclosed in the financial statements.

- Inventory provisioning (Also refer Note 2.07)

The calculation of inventory provisions requires judgement by management of the expected value of future sales. Further if the carrying value of inventory is higher than the expected recoverable value, the Company makes provisions writing inventory down to its net recoverable value. The inventory is initially assessed for impairment by comparing inventory levels to recent utilization rates and carrying values to historical selling prices. A detailed review is completed for inventory lines identified in the initial assessment considering sales activity, order flow, customer contracts and current selling price.

- Provision for income taxes and deferred taxes – (Also refer Note 2.16)

Significant judgements are involved in determining the provision for income taxes including judgement on whether tax positions are probable of being sustained in tax assessments.

A tax assessment can involve interpretation issues, which can only be resolved over extended time periods. The Company reviews the carrying amount of deferred tax assets at the end of each reporting period.

2.24 Recent accounting pronouncements

A Superannuation Fund

Invel Transmission Limited Superannuation Fund Trust ("The Trust") was incorporated to provide superannuation amount to the eligible employees of the Company on their retirement or resignation from the Company. The Trust has taken Employees Group Superannuation Scheme policy from Life Insurance Corporation of India (LIC).

The quarterly contributions equivalent to 15% of the Basic Salary of eligible employees are paid to LIC which manages the fund.

B Provident Fund

Provident fund benefits for certain eligible employees were managed by the Company through the Employees' Provident Fund Trust in accordance with the Employees' Provident Funds and Miscellaneous Provisions Act, 1952. The plan guarantees interest at the rate notified by the Provident Fund authorities. Contributions made by both the employer and the employee, together with the accumulated interest thereon, are payable to employees upon their separation from the Company or retirement, whichever occurs earlier. The benefits vest immediately upon the employee rendering services.

The Company had an obligation to make good any shortfall between the return on the Trust's investments and the interest rate notified by the Provident Fund authorities. The Company's obligation in this regard is actuarially determined and provided for when circumstances indicate that the Trust may not be able to generate sufficient returns to meet the interest rates notified by the Government.

Effective January 1, 2026, the Company surrendered its exemption to the Government of India pursuant to a resolution passed by the Board of Trustees of the Invel Transmission Limited Employees' Provident Fund Trust on August 25, 2025.

(ii) Defined benefit plans

A Gratuity plan

The Company operates gratuity plan administered through Gratuity Trust which further invests in Life Insurance Corporation of India (LIC) under its group gratuity scheme. Every employee is entitled to a benefit equivalent to fifteen days salary last drawn for each completed year of service in line with the Payment of Gratuity Act, 1972. The same is payable at the time of separation from the Company or retirement, whichever is earlier. The benefits vest after five years of continuous service. The Company pays contribution to LIC to fund its plan.

The present value of the Gratuity and related current service cost are measured using the Projected Unit Credit method. The valuation of gratuity liability and corresponding gratuity fund are carried out by qualified Actuary using actuarial valuations techniques as at balance sheet date.

These plans typically expose the Company to actuarial risks such as: interest rate risk, longevity risk, salary risk and Investment risk.

Interest risk	The defined benefit obligation calculated uses a discount rate based on government bonds. If bond yields fall, the defined benefit obligation will tend to increase.
Longevity risk	The present value of the defined benefit plan liability is calculated by reference to the best estimate of the mortality of plan participants both during and after their employment. An increase in the life expectancy of the plan participants will increase the plan's liability.
Salary risk	The present value of the defined benefit plan liability is calculated by reference to the future salaries of plan participants. As such, an increase in the salary of the plan participants will increase the plan's liability.
Investment Risk	This may arise from volatility in asset values due to market fluctuations and impairment of assets due to credit losses. LIC of India primarily invests in debt instruments such as Government securities and highly rated corporate bonds wherein the risk of downward fluctuation in value is minimal.

Derivative contracts: The Company has entered into foreign currency forward contracts to manage its exposure to fluctuations in foreign exchange rates. These financial exposures are managed in accordance with the Company's risk management policies and procedures. Fair value of derivative financial instruments are determined using valuation techniques based on information derived from observable market data and using valuation provided by authorised dealers dealing in foreign exchange.

29.2 Financial risk management objective and policies

The Company's activities expose it to market risk, liquidity risk and credit risk. In order to minimise any adverse effects on the financial performance of the Company, derivative financial instruments, such as foreign exchange forward contracts are entered to hedge certain foreign currency risk exposures. Derivatives are used exclusively for hedging purposes and not as trading or speculative instruments.

This note explains the sources of risk which the entity is exposed to and how the entity manages the risk and the impact of hedge accounting in the financial statements.

(i) Credit risk

Credit risk refers to the risk that a counterparty will default on its contractual obligations resulting in financial loss to the Company. The Company's exposure to credit risk primarily arises from trade receivables, balances with banks and security deposits. The credit risk on bank balances is limited because the counterparties are banks with good credit ratings. Trade receivables mainly consist of Original Equipment Manufacturers as customers. Ongoing credit evaluation is performed on the financial condition of accounts receivable. The Company's policies on assessing expected credit losses is detailed in note 2.11 to the financial statements.

(ii) Liquidity risk

Liquidity risk refers to the risk that the Company can not meet its financial obligations. The objective of liquidity risk management is to maintain sufficient liquidity and to ensure funds are available for use as per the requirements. The Company does not have any long-term borrowings and maintains sufficient liquidity; hence, it is not exposed to any significant liquidity risk (refer Note 29.3). The Company has access to the borrowing facilities to honour any liquidity requirements arising for business needs. The Company manages liquidity through cash and cash equivalents, operational cash flows and available banking facilities. Management monitors rolling cash flow forecasts to ensure sufficient liquidity is maintained.
